The three parts, jacket, sleeves and cap must be described according to this order and can be composed with 2 colours, exceptionally three. Diagrams differing from those listed above and previously assigned are still in force, but can only be authorized again at the Stewards of France Galop discretion.

Furthermore, the Stewards may allow an owner who has registered his colours abroad and whose racing colours are not matching the standard diagrams, to race under the rules of Code des Courses au Galop with the same colours as the ones registered abroad.
